## Title I Parent Involvement Policy

Upper Lake Union High School District is a single comprehensive high school district. We provide a variety of learning options that include a continuation school, community day school, independent study program, and an adult school. Upper Lake High School is a school-wide Title I program school. (All learning options, including the continuation school, community day school, independent study program and adult school are referred to as *Upper Lake High School District*, inclusively, throughout this policy.)

*Upper Lake High School District* believes in the importance of good communication between parents/guardians and the school staff in order to build a successful learning environment for all students. It is our desire to provide multiple opportunities for parents, students, and school staff to establish strong, meaningful, and lasting connections.

Parental involvement means the participation of parents, students, and school staff in a variety of activities that support student academic and social wellbeing. Opportunities include: volunteering on campus, Parent Advisory, Booster Club, extra-curricular events, support drivers to events, tutoring, and School Site Council. Upper Lake High School District believes:

- > That parents play an integral role in assisting their student's learning.
- That parents are encouraged to be actively involved in their student's education.
- > That parents are partners in their student's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.

This Parent Involvement Policy has been developed jointly with input from staff, students, and parents. It has been reviewed by the School Site Council and Board of Education. Parents are encouraged to review its contents and make suggestions as appropriate.

#### **School Parental Involvement Policy:**

*Upper Lake High School District* encourages parent involvement in the development of its Schoolwide Plan for Student Achievement, as well as the Title I Parent Involvement Plan and Compact. This is accomplished on a quarterly basis through the School Site Council, Parent Advisory Committee, and Student Advisory Committee. - Annually during registration, *Upper Lake High School District* convenes a meeting to inform parents of Title 1 requirements and the right of parents to be involved.
- ➤ Upper Lake High School District holds monthly Parent Advisory and Student Advisory meetings at flexible times to meet the needs of the parents (mornings and evenings). Upper Lake High School District maintains a School Site Council comprised of certificated and classified staff, parents and students, and meets quarterly. If requested, regular meetings are held to focus on the educational decisions related to Title 1 students.
- ➤ The parent and student advisory meetings involve Title 1 parents and students in the planning, review and improvement of *Upper Lake High School District's* Title 1 programs and the parent involvement policy which is available in hard copy and online at ulhs.net.
- > *Upper Lake High School District* provides parents with timely information regarding Title 1 programs.
- ➤ The Site Council is responsible for reviewing student academic assessment data as it pertains to *Upper Lake High School District's* five adopted goals and nine essential components. The Council makes recommendations for improving student success through the development of programs as well as fiscal support. Recommendations are made involving the development of the Single School Plan for Student Achievement, and forwarded to the Board of Education for final approval.
- ➤ Upper Lake High School District provides parents with an explanation of the curriculum used, the assessments used to measure student progress, and the proficiency levels students are expected to meet.
- ➤ During registration a review of the Parent Involvement Policy will be conducted and suggestions forwarded to the School Site Council.
